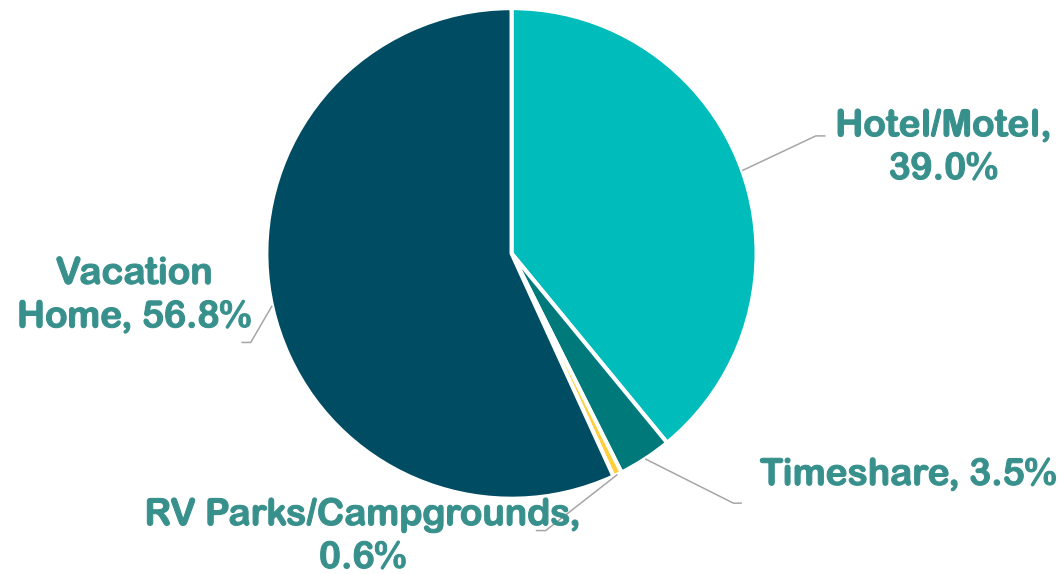
Collections for business in July total \$5,674,838, an increase of 4.60% compared to the prior year.
